Trail signing is complete and the trails were groomed once. New 100 ft. strip of trail will be added as land becomes available south of Eagle Dr. on County Z.

Adams County Snowmobile Association is discussing the opening of trails and criteria needed to do so. Want to change the snow total from the current 6" and the opening of sections versus the entire county.

The AWSC wants to raise club dues to \$12.00 as well as change registration from July 1 to June 30 for the 2020 season. Club will align with AWSC decisions.
